Important Information

Travel Insurance

We all hate missing a vacation! But losing money paid for that vacation is more heartbreaking. That is why travel insurance is required for all travelers. Passport Validation

Your passport must be valid and remain valid for at least six (6) months after travel. Your passport should not expire before June 2, 2025. A copy of your passport must be submitted with your Getting To Know You (GTKY) form.

The STEP Program

Smart Travel Enrollment Program is operated by the US Department of State. You are encouraged to sign up for this program as it is helpful in assisting the local embassy to reach you in case of an emergency.

Room Mate Matching

I will match you with a roommate. When completing your GTKY form, select double occupancy. You will be matched with a roommate once you have paid at least 50% of the balance of your trip and provided the person you will be matched with has also paid at least 50% of his/her balance.

Cancellation Policy

Deposits are non-refundable. However if canceled more than 60 days before the travel date, you can transfer the funds to another date or trip. If canceled less than 60 days before the trip, deposits are non-refundable and non-transferable. For the balance amount, the below cancellation fee will be applicable.

- 60-31 days prior to arrival, 40% of the tour
- 30-07 days prior to arrival, 75% of the tour
- 06 days –72 hours prior to arrival, 100% of the tour ~ NO REFUND

- Extra food & beverages that are not specified in the program
- Personal expenses and optional tours
- Tipping for tour guide and driver
- International & Domestic airfare

Visa & Travel Insurance
